4. FIRST AID MEASURES

First aid measures

Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing before reuse. If skin irritation persists, see a physician. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is required.

Symptoms

The product causes irritation of eyes, skin and mucous membranes. Prolonged or repeated contact may be drying to skin.

Indication of any immediate medical attention and special treatment needed

Note to physicians

Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.
